

**Carlisle City Council**  
**Meeting Minutes**  
**July 16, 2024**

Mayor Ray Glover declared a quorum and called the regular meeting of the Carlisle City Council to order on Tuesday, July 16, 2024 at 6:00 PM, in the Council Meeting Room at the Carlisle Civic Center.

He has had a couple applicants and hopes to hire soon but until then with two guys watering plants a couple hours every morning and the other two at water plant it makes getting it all done difficult.
