Carlisle City Council Meeting Minutes August 19, 2025

The regular meeting of the Carlisle City Council was held on Tuesday, August 19, 2025, at 4:00 p.m. in the Council Room.

Present

Mayor Jon Plafcan, Council Members: Anne Anderson, Caleb Swears, Mary Eddleman, Chris Davidson, Andrew Silverman, City Clerk Sissy Ingle and City Attorney Mike Stuart were present.

The meeting was called to order by Mayor Jon Plafcan, who led the Pledge of Allegiance and the opening prayer.

Mayor Plafcan read a Community Safety Statement to address concerns regarding public safety, protecting our community's reputation and moving forward.

July Minutes

Motion made by Council Member Caleb Swears and seconded by Council Member Chris Davidson to approve the July minutes as presented.

July Financial Reports

A discussion was held regarding the \$21,379.96 deposited into the Water/Sewer Short-Lived Asset Fund. These funds represented APERS retirement money returned to the City by a former employee as restitution for stolen funds. Since there was no documentation showing which accounts the stolen funds had originally been taken from, it was determined that the restitution could be deposited into the Short-Lived Asset Fund. This decision was made because loan conditions had not been met for many years, and USDA required the City to bring accounts up to date as soon as possible. Monthly deposits are now being made into both the Short-Lived Asset Fund and the Debt Service Account from Water and Sewer revenues. This action is part of the City's effort to comply with loan requirements and correct prior years of unappropriated funds.
