ORDINANCE NO. 346

ORDINANCE TO AUTHORIZE GOLF CARTS ON CITY STREETS

Pursuant to Arkansas Code Annotated §14-54-1410 golf carts may be operated by the owner on City Streets as set forth in this Section.

- SECTION 1. An Operator must be at least 16 years or older and have a valid driver's license.
- SECTION 2. The golf cart must be battery powered only.
- SECTION 3. The owner must secure an application for permit from the City. Permits shall cost \$25.00 annually.
- SECTION 4. Operation of the vehicle must conform to all Ordinances, statutes, and laws dealing with motorized vehicles. No golf cart may be operated on any federal or state roads.
- SECTION 5. The owner must have a valid liability insurance policy similar to that required to operate a motor vehicle.
- SECTION 6. Golf carts can only be operated from sunrise to 10:00 p.m.
- SECTION 7. Golf carts must have lights, seat belts, front and back, turn signals and any other required equipment a vehicle must have driven on federal or state roads and streets in the State of Arkansas.
- SECTION 8. The golf cart must not exceed 25mph.
- SECTION 9. Penalty. Any person violating any of the provisions of this Ordinance shall, upon conviction, be punished by a fine of \$25.00. The penalty for subsequent offenses shall be:
 - 1. \$50.00 for a second offense that occurs within twelve (12) months of the prior offense.
 - 2. \$100.00 for the third offense that occurs within twelve (12) months of any prior offenses.
 - 3. \$200.00 for the fourth and all subsequent offenses that occur within twelve (12) months of any prior offenses.

This Ordinance shall be in full force and effect from and after its passage and publication.
